DIRECTOR POSITIONS FOR PUBLIC BODIES BOARDS**

The Independent Selection Committee (ISC) is pleased to invite applications from qualified individuals interested in serving on the Board of Directors for the following Public Bodies:

(1) Accident Compensation Corporation (ACC) – one vacancy

- 1.1 A person with extensive experience in community development, with advocacy skills and actively participates in traditional village governance (alii ma faipule, saaoa ma tamaitai, tupulaga talavou).

(2) Development Bank of Samoa (DBS) – three vacancies

- 2.1 A person with proven success in operating Small Medium Enterprises and has substantial knowledge and experience of debt management.
- 2.2 A person with extensive experience in community development, with advocacy skills and actively participates in traditional village governance (alii ma faipule, saaoa ma tamaitai, tupulaga talavou).
- 2.3 A person with extensive and successful experience in banking and investment on business development in particular SMEs.

(3) Electric Power Corporation (EPC) – one vacancy

- 3.1 A person with extensive and successful experience in financial management preferably on investments in the Energy Sector/Industry.

(4) Gambling Control Authority (GCA) – three vacancies

- 4.1 A person with an accounting qualification and experience in accounting.
- 4.2 A qualified person who is an experienced practitioner under the Lawyers and Legal Practice Act 2014.
- 4.3 A person representing the interests of sports.

(5) Land Transport Authority (LTA) – one vacancy

- 5.1 An appropriately qualified engineer with extensive and successful experience in civil works with preferably a sound understanding of road infrastructure, drainage and maintenance.

(6) Samoa Housing Corporation (SHC) – one vacancy

- 6.1 A person with proven experience in community project implementation with robust knowledge of the Government's development agenda related to the housing industry. Must have sound understanding of the Corporation's mandate and have extensive decision-making experience.

(7) Samoa National Provident Fund (SNPF) – one vacancy

- 7.1 A person with extensive experience in community development, with advocacy skills and actively participates in traditional village governance (alii ma faipule, saaoa ma tamaitai, tupulaga talavou).

(8) Samoa Ports Authority (SPA) – one vacancy

- 8.1 A person with proven experience in community project implementation with robust knowledge of the Government's development agenda related to port management and operations.

(9) Scientific Research Organization of Samoa (SROS) – one vacancy

- 9.1 A suitable person with extensive research experience relevant the organization's mandate.

(10) Samoa Shipping Corporation (SSC) – one vacancy

- 10.1 A person with extensive experience in community development, with advocacy skills and actively participates in traditional village governance (alii ma faipule, saaoa ma tamaitai, tupulaga talavou).

(11) Samoa Shipping Services (SSS) – one vacancy

- 11.1 A person with experience in supporting youth development programs through counselling and mentoring. An advocacy in village traditional council is also required.

(12) Samoa Tourism Authority (STA) – one vacancy

- 12.1 A person with extensive experience in community development, with advocacy skills and actively participates in traditional village governance (alii ma faipule, saaoa ma tamaitai, tupulaga talavou).

(13) Samoa Water Authority (SWA) – one vacancy

- 13.1 A person with extensive experience in community development, with advocacy skills and actively participates in traditional village governance (alii ma faipule, saaoa ma tamaitai, tupulaga talavou).

All those who apply must identify the Public Body and the specific Director position he/she is applying for. Should you wish to be considered for a specific position in more than one Public Body Board or more than one position in the same Public Body Board you may do so. Please indicate in Section 9 of the Application Form your order of preferences up to three.

All applicants including former Directors must submit the following:

- (1) Completed Director's Application form;
- (2) Curriculum Vitae (CV) and certified copies of Qualifications & Certificates;
- (3) Additional supporting documents;
- (4) Police Report (*must be dated within the past 12 months*) and;
- (5) At least two (2) References from the nominated referees (*must be dated within the past 12 months*).

The Director's *Application form* can be uplifted from the Ministry for Public Enterprises, Level 1, SNPF Plaza (behind DMC) or can be downloaded from the MPE website at www.mpe.gov.ws.

Eligibility

All applications will be considered; however, a person must not apply if his or her background falls into any of the following disqualification criteria stated in the Public Bodies (Performance & Accountability) Act 2001.

- under 21 years of age;
- an un-discharged bankrupt;
- adjudged to be mentally defective under the Mental Health Act 2007;
- disqualified from being a Director under sections 202, 203 or 204 of the Companies Act 2001, or disqualified previously under section 189 of the Companies Act 1955;
- is convicted in Samoa or elsewhere of an offence punishable by death or by imprisonment for a term of 2 years or more;
- was a director or manager of a company at the time the company has been placed in receivership/liquidation;
- has a history of failing to repay on time any money legally owed to any Public Body;
- is an employee, director or shareholder in another business that is potentially in conflict with the Public Body;
- A Member of Parliament, Public Servant, or constitutional officer;
- A person employed or engaged by a PB is not eligible for appointment as a director;

Submitting an application signifies the person's agreement for the ISC to carry out investigations relating to these criteria.

Applications close at 4.00pm on Friday 12th December 2025.
